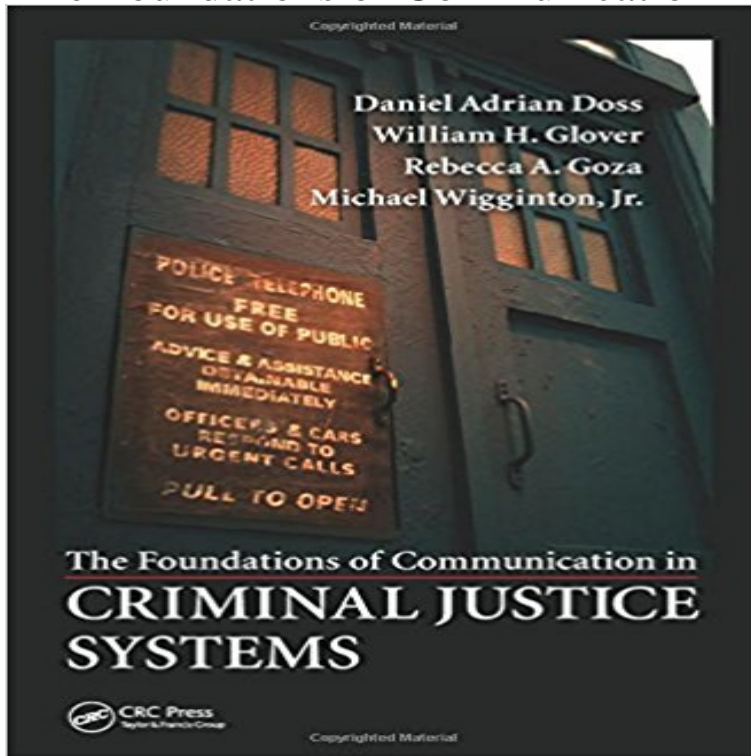


# The Foundations of Communication in Criminal Justice Systems
