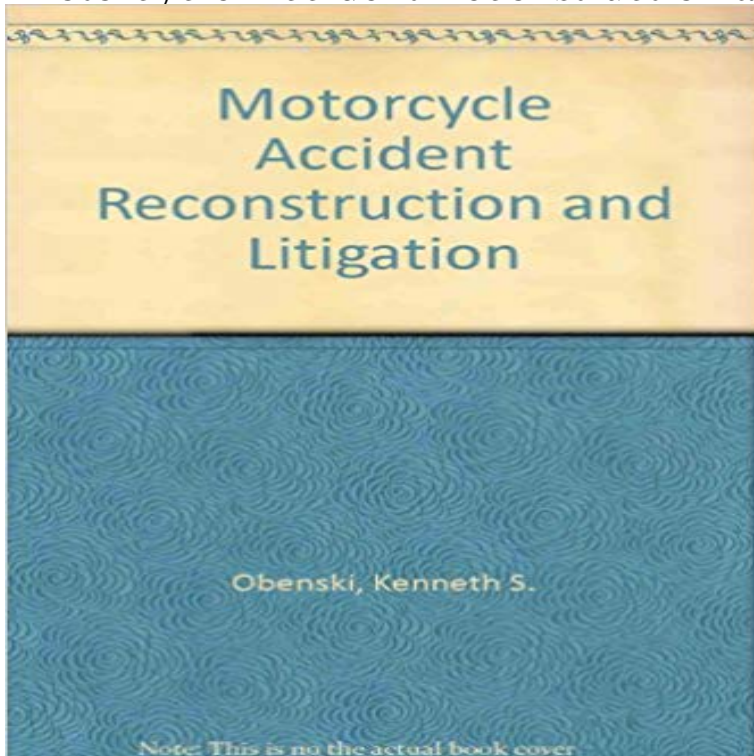


Motorcycle Accident Reconstruction and Litigation
