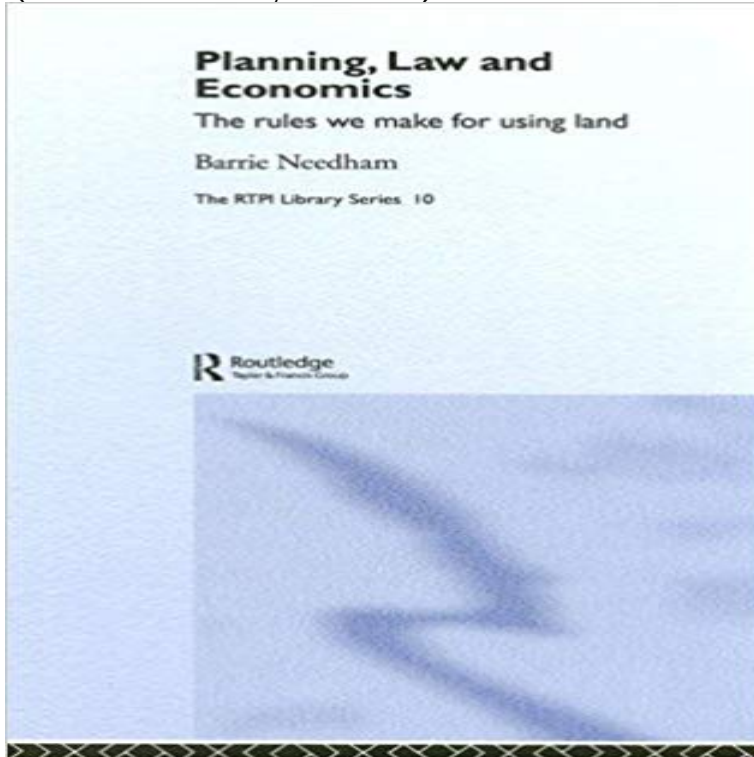


Planning, Law and Economics: The Rules We Make for Using Land (RTPI Library Series)
