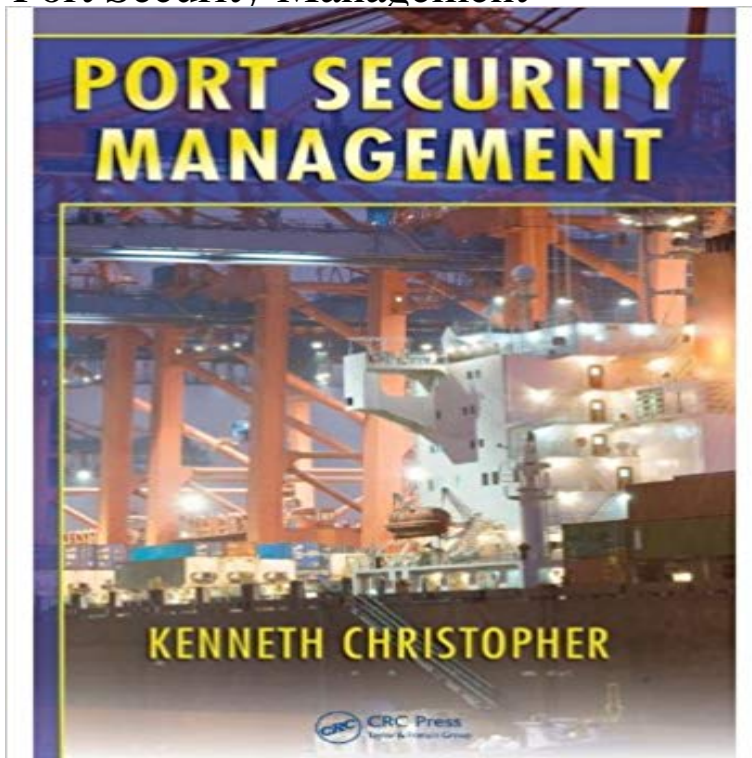


## Port Security Management
