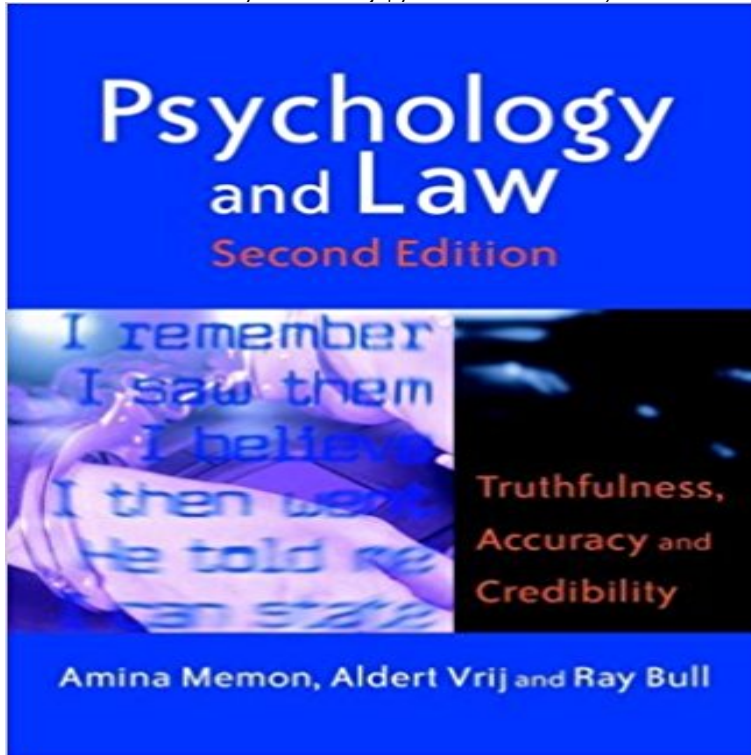


Psychology and Law: Truthfulness, Accuracy and Credibility (Wiley Series in Psychology of Crime, Policing and Law)
