


# Refugee Law in the UK: A practical guide to refugee law and practice



The 1951 UN Convention on the Status of Refugees is the legal instrument that has saved the most lives in human history. It is a hugely important convention and understanding its terms and how it operates in practice in the refugee status determination process is, inevitably, critically important for any lawyer or student practicing or learning about refugee and asylum law. This is a clearly written and accessible guide to the meaning of the refugee definition. It includes material on how the definition operates in practice in the UK, including common arguments, scenarios and examples. The last part of the ebook looks fairly briefly at the cessation, exclusion and refoulement clauses of the convention. Ideal for students or lawyers, this guide distills a decade and a half of learning and practice from the author, Colin Yeo, editor of the Free Movement blog and a barrister at Garden Court Chambers in London, the leading immigration set of chambers in the UK.
