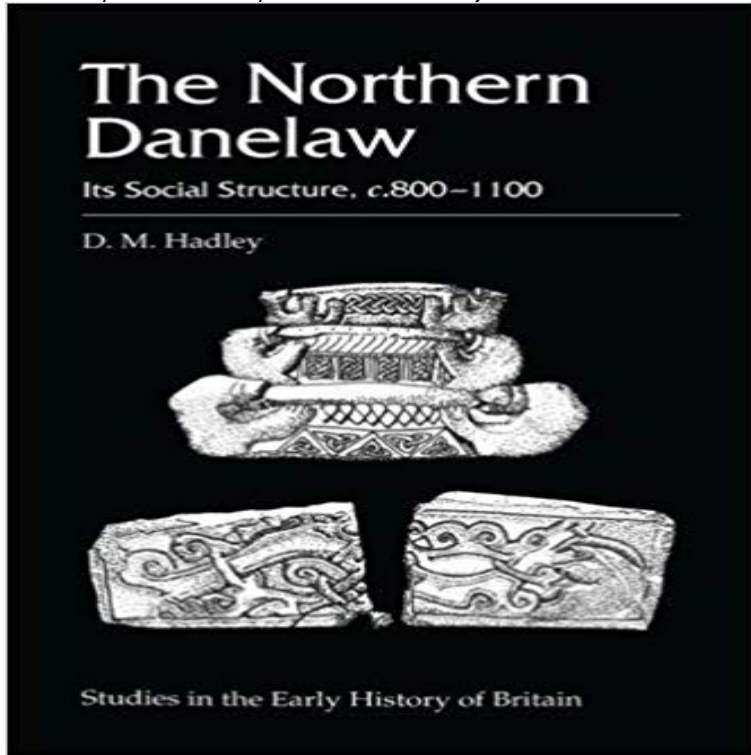


The Northern Danelaw: Its Social Structure, c.800-1100 (Studies in the Early History of Britain)

Hadley also explains the peculiarities of the northern Danelaw and reassesses the impact of the Scandinavian settlements on its society and culture. A detailed local study is combined with a consideration of wider issues concerning Anglo-Saxon England and land, and short-term changes unrelated to successive conquests.
