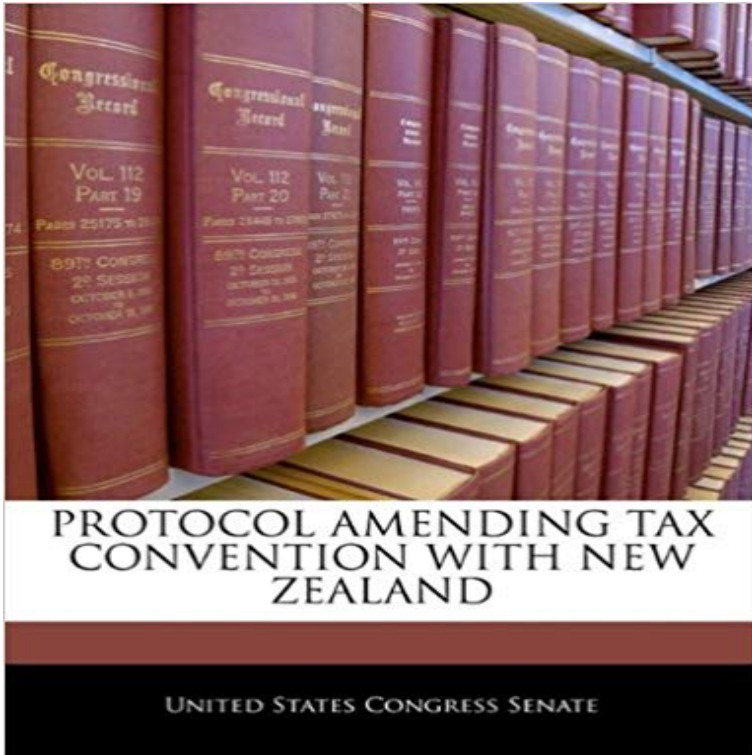


# PROTOCOL AMENDING TAX CONVENTION WITH NEW ZEALAND
