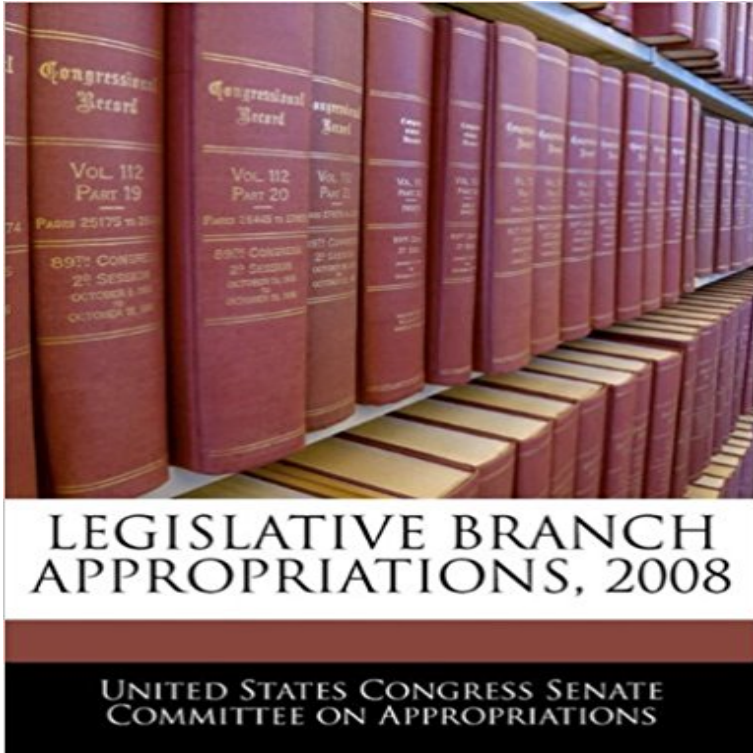


# LEGISLATIVE BRANCH APPROPRIATIONS, 2008
