

The essential role that the notion of corporate identity plays is evident in various salvific contexts. expressions in which the earliest believers soteriological interpretation of Jesus death resurrection finds expression; namely, Pauls understanding and usage of the dying for and surrender formulas, his conception of the believers eschatological resurrection, and his understanding of the Lords Supper. On the basis of this investigation, it becomes evident that the corporate understanding that Christian believers are united with Christ is one of the essential foundations of the earliest believers conception of salvation. Pauls essential notion of salvation is that of participationism. Because of their unity with Christ, the believers are conceived by Paul as sharing or participating in Christs fate, including both his death and his resurrection
