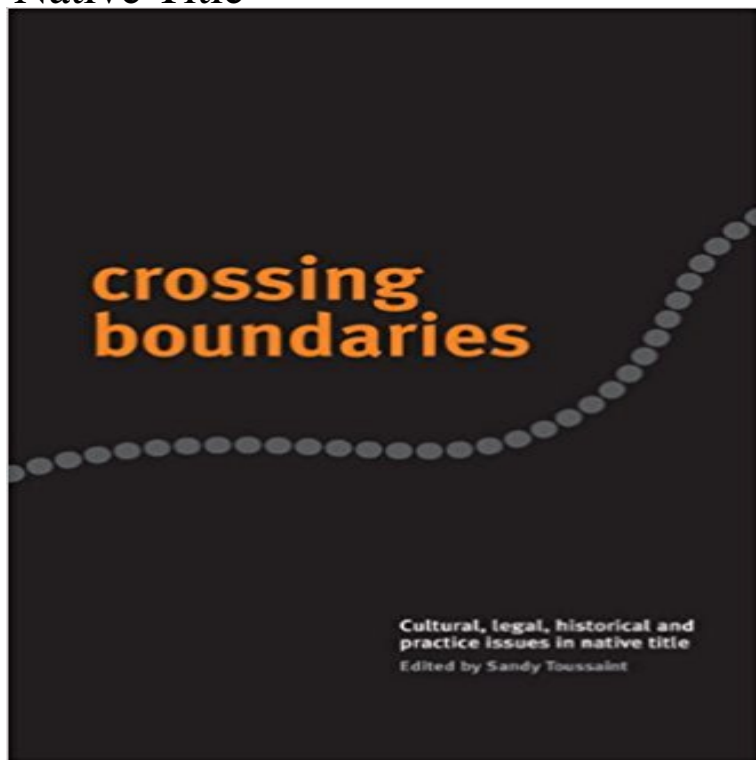


Crossing Boundaries: Cultural, Legal, Historical and Practice Issues in Native Title
