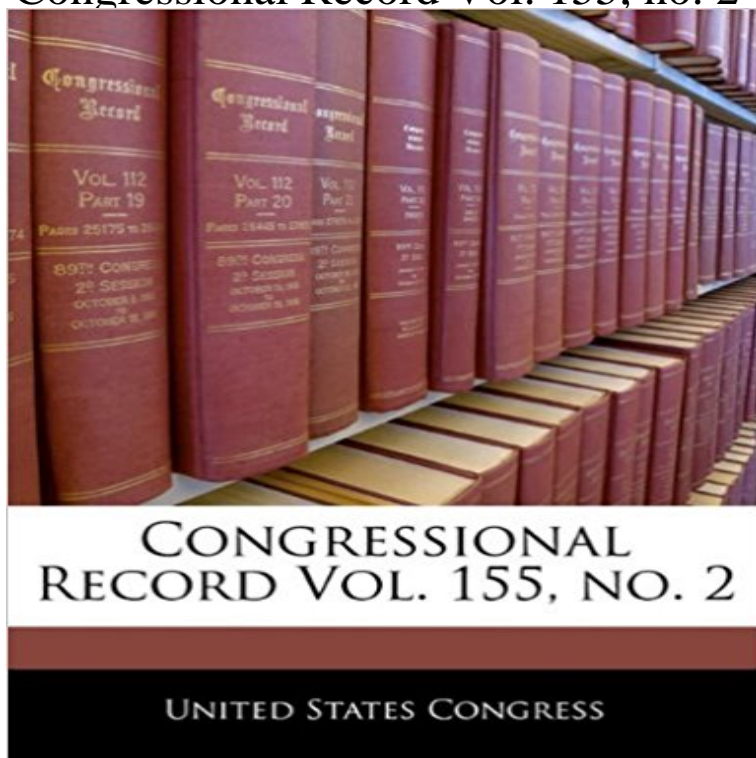


## Congressional Record Vol. 155, no. 2
