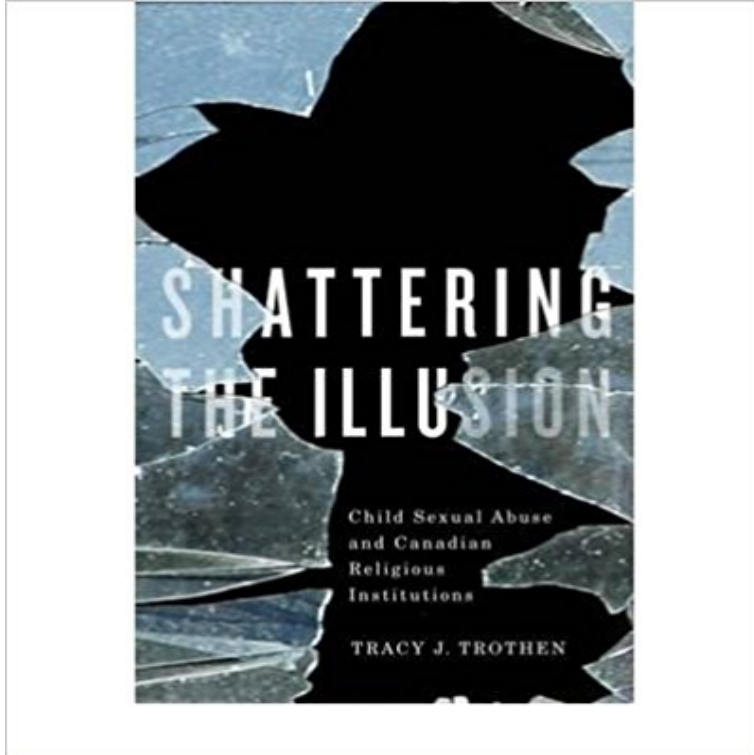


Shattering the Illusion: Child Sexual Abuse & Canadian Religious Institutions (Paperback) - Common
