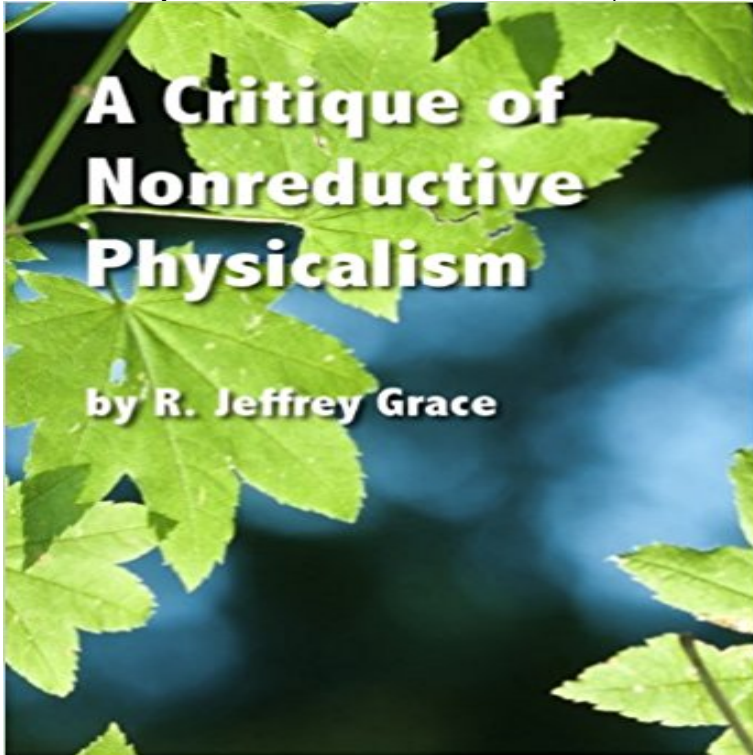


A Critique of Nonreductive Physicalism
