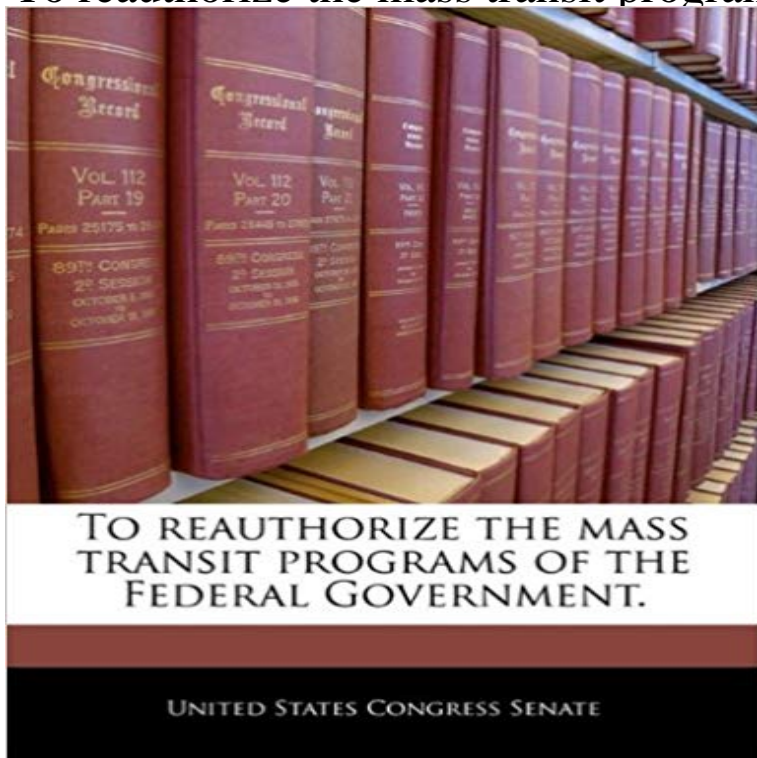


# To reauthorize the mass transit programs of the Federal Government.
