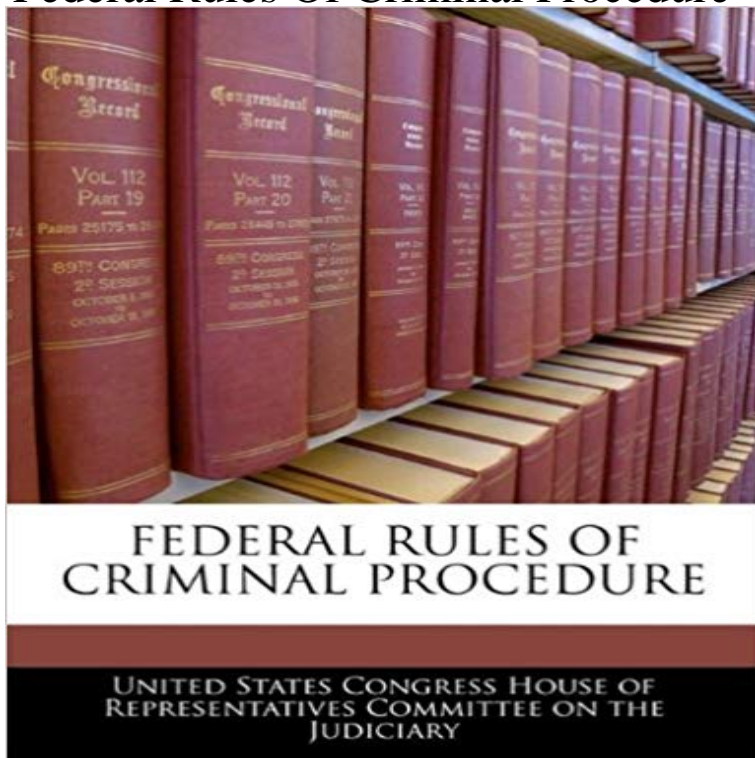


# Federal Rules Of Criminal Procedure
