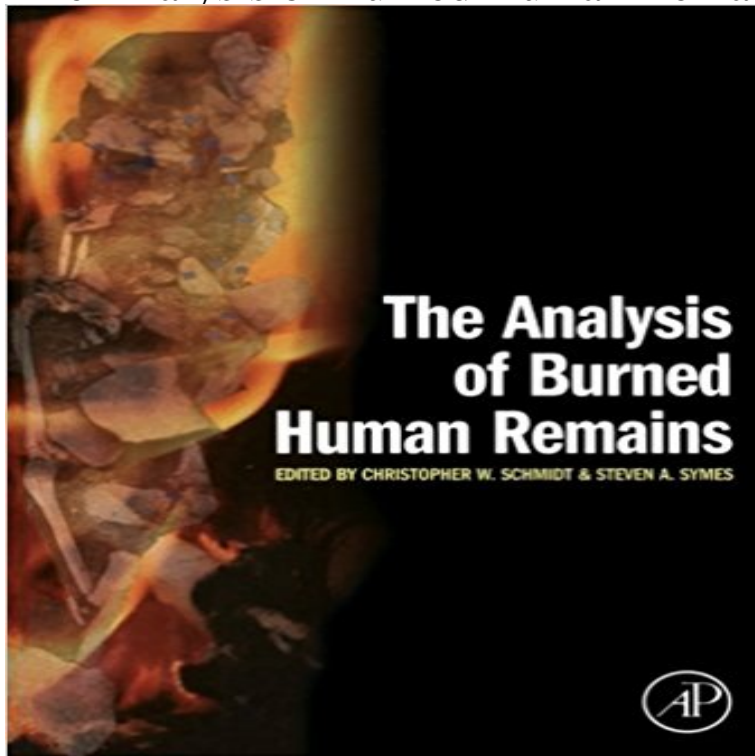


The Analysis of Burned Human Remains
