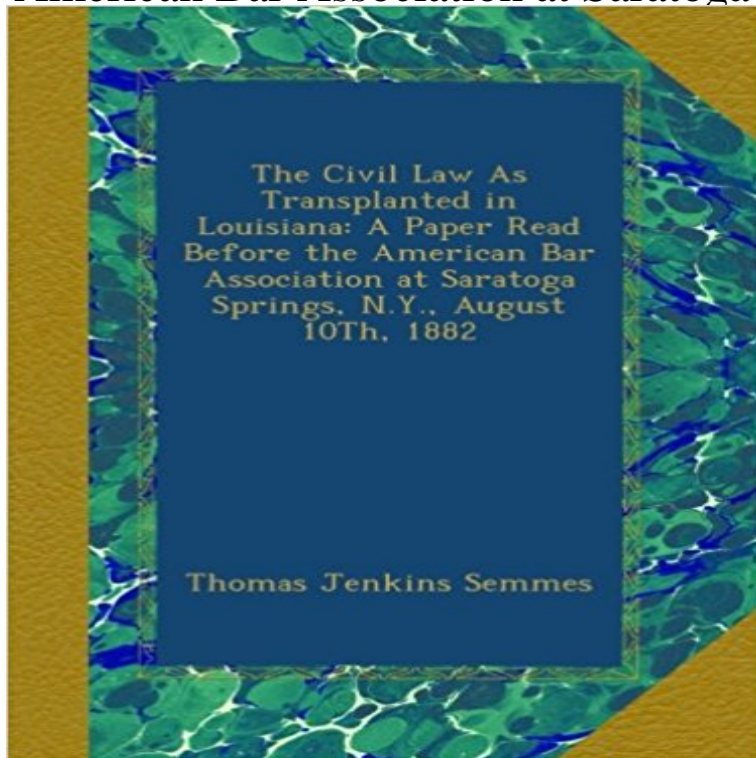


The Civil Law As Transplanted in Louisiana: A Paper Read Before the American Bar Association at Saratoga Springs, N.Y., August 10Th, 1882
