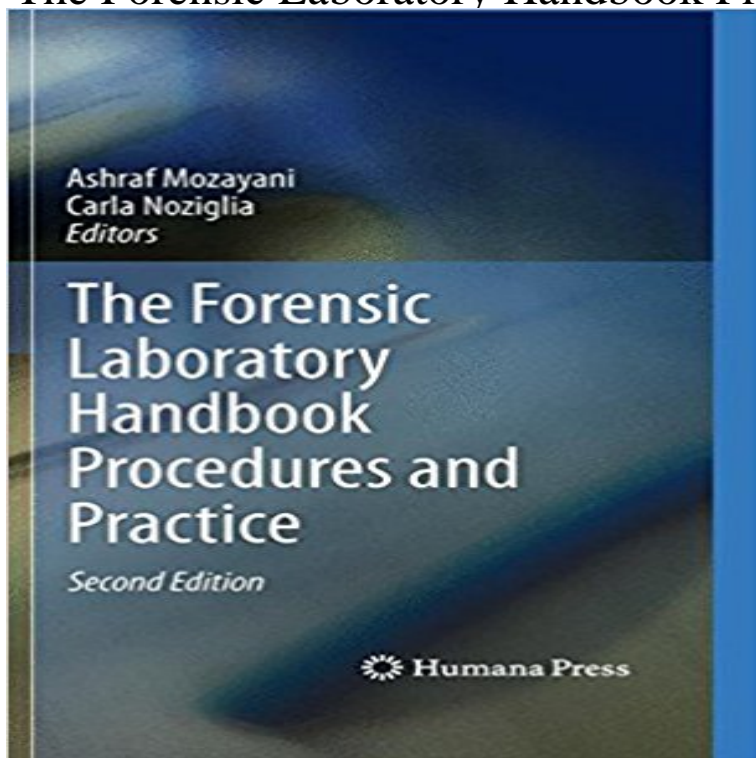


The Forensic Laboratory Handbook Procedures and Practice
