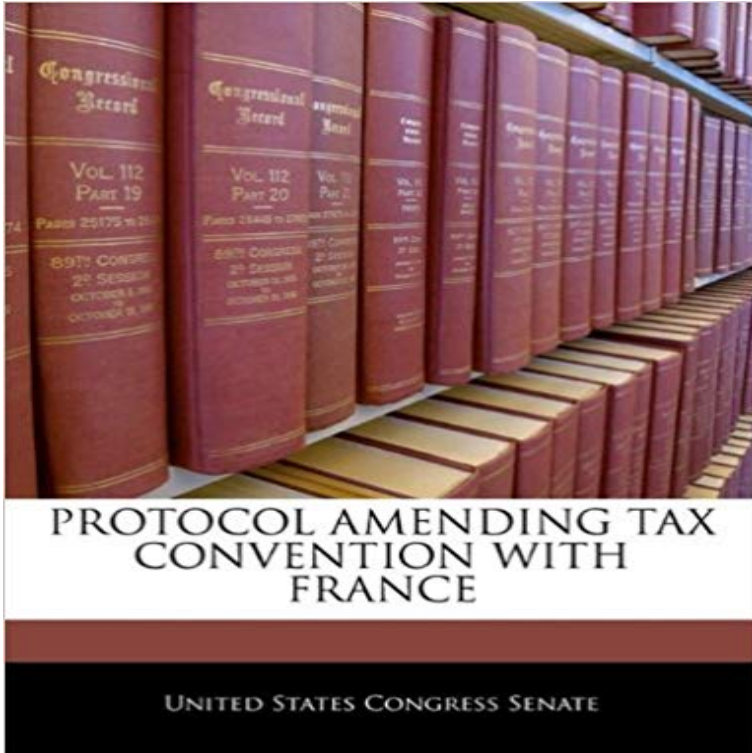


PROTOCOL AMENDING TAX CONVENTION WITH FRANCE
