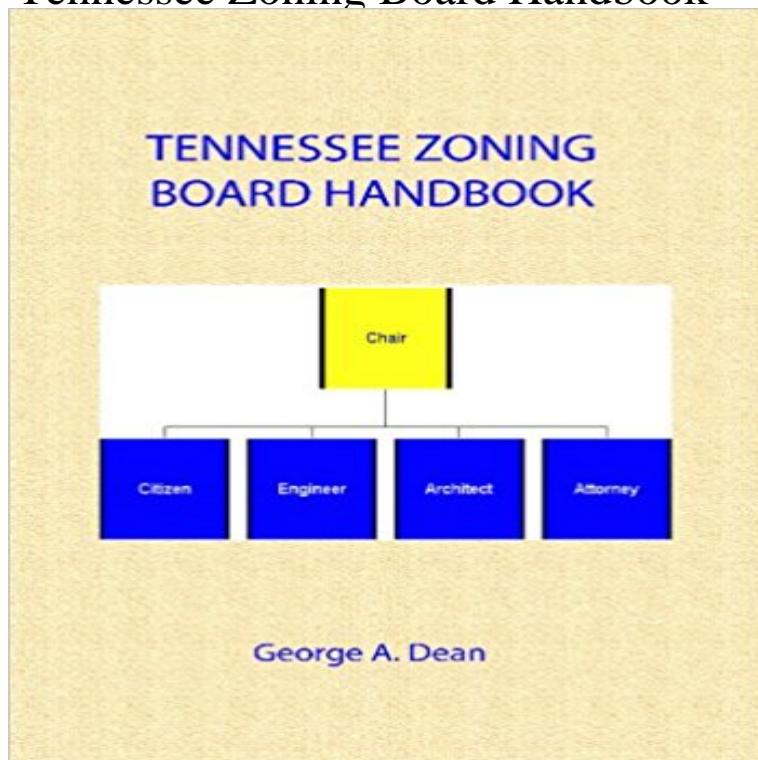


# Tennessee Zoning Board Handbook
