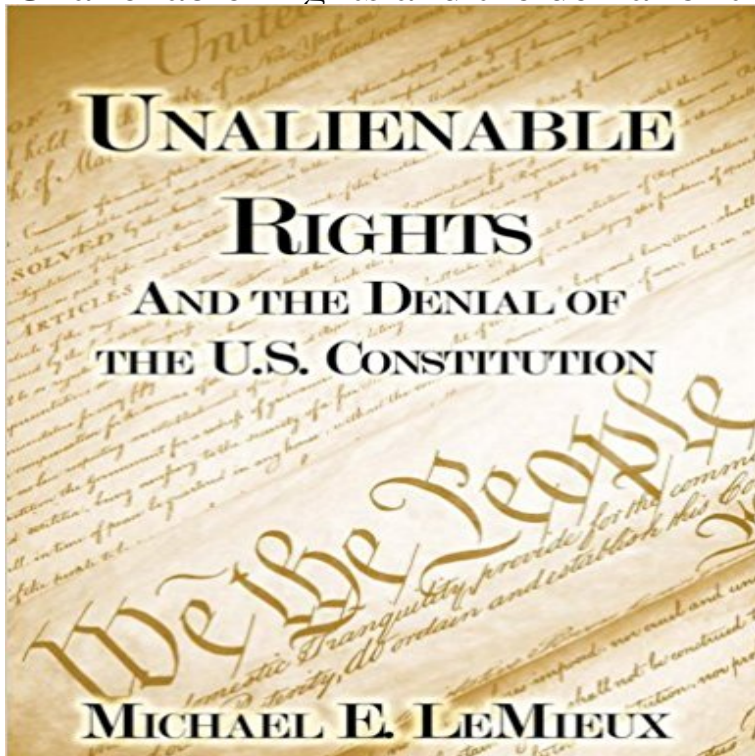


## Unalienable Rights and the denial of the U.S. Constitution
