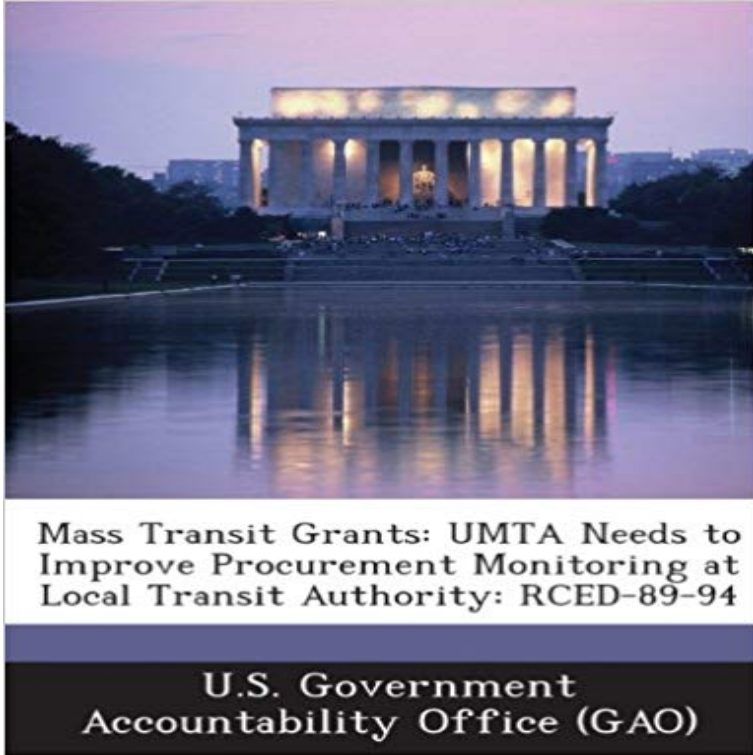


Mass Transit Grants: UMTA Needs to Improve Procurement Monitoring at Local Transit Authority: RCED-89-94
