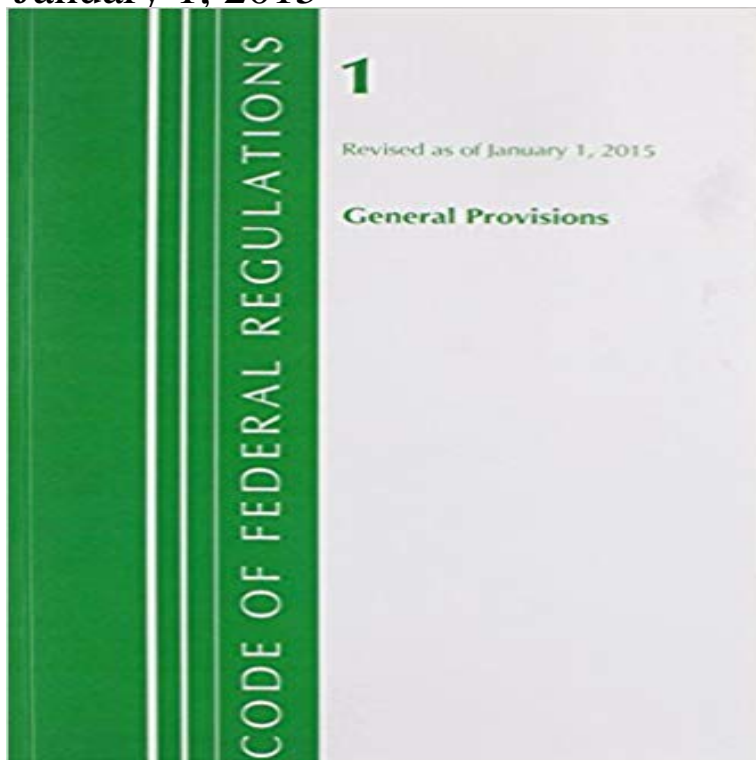


# Code of Federal Regulations, Title 01 General Provisions, Revised as of January 1, 2015
