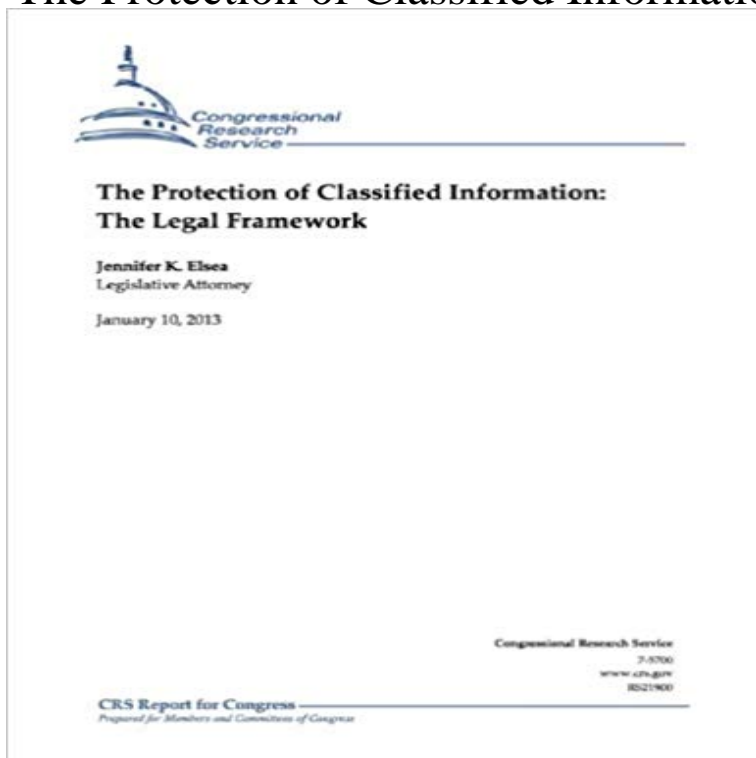


# The Protection of Classified Information: The Legal Framework
