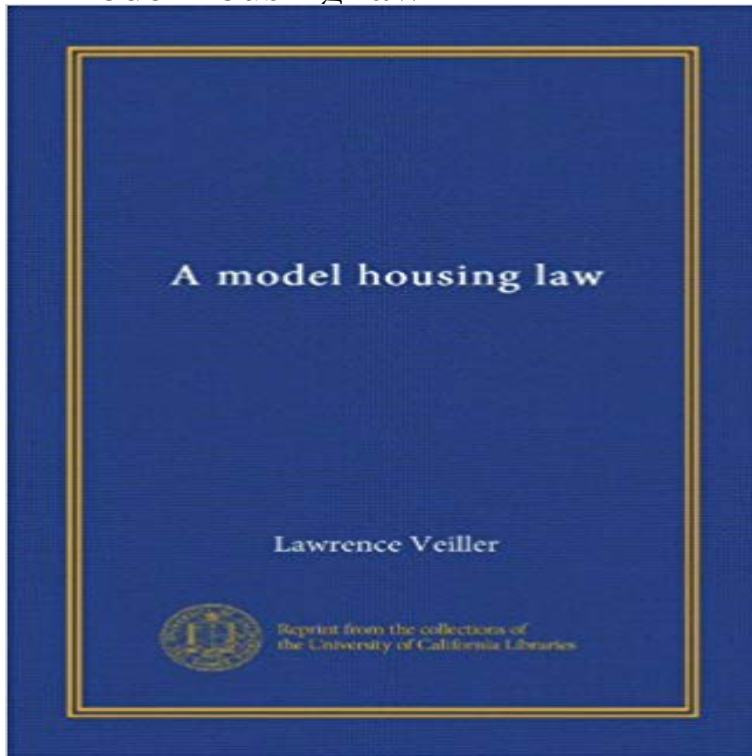


A model housing law
